Mr. FRELINGHUYSEN (for himself, Mr. HUNT, Mr. SANDMAN, Mr. HOWARD, Mr. THOMPSON of New Jersey, Mr. CAHILL, Mr. WIDNALL, Mr. JOELSON, Mr. HELSTOSKI, Mr. RODINO, Mr. MINISH, Mrs. DWYER, Mr. GALLAGHER, Mr. DANIELS, and Mr. PATTEN) introduced the following bill; which was referred to the Committee on Interior and Insular Affairs

A BILL

To designate certain lands in the Great Swamp National Wildlife Refuge, Morris County, New Jersey, as wilderness.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 *That, in accordance with section 3 (c) of the Wilderness Act*
4 *of September 3, 1964 (78 Stat. 890, 892; 16 U.S.C. 1132*
5 *(c)), certain lands in the Great Swamp National Wildlife*
6 *Refuge, New Jersey, which comprise about three thou-*
7 *sand seven hundred and fifty acres and which are depicted as*
8 *wilderness units on a map entitled "M. Hartley Dodge Wil-*
9 *derness and Harding Wilderness—Proposed" and dated*

1 September 1967 are hereby designated as wilderness. The
2 map shall be on file and available for public inspection in the
3 offices of the Bureau of Sport Fisheries and Wildlife, De-
4 partment of the Interior.

5 SEC. 2. The area designated by this Act as wilderness
6 shall be known as "Great Swamp Wilderness" and shall be
7 administered by the Secretary of the Interior in accordance
8 with the applicable provisions of the Wilderness Act.

9 SEC. 3. Except as necessary to meet minimum require-
10 ments in connection with the purposes for which the area is
11 administered (including measures required in emergencies
12 involving the health and safety of persons within the area),
13 there shall be no commercial enterprise, no temporary or
14 permanent roads, no use of motor vehicles, motorized equip-
15 ment or motorboats, no landing of aircraft, no other form of
16 motorized transport, and no structure or installation within
17 the area designated as wilderness by this Act.
