A BILL

To amend the Food Stamp Act of 1964, as amended, for the purposes of authorizing appropriations for the fiscal years ending June 30, 1969, June 30, 1970, June 30, 1971, and June 30, 1972, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That subsection (a) of section 16 of the Food Stamp Act
4 of 1964 is amended (A) by deleting from the first sentence
5 the phrase "not in excess of \$225,000,000 for the fiscal
6 year ending June 30, 1969;" and inserting in lieu thereof
7 the following: "such sums as may be necessary for each of

1 the fiscal years ending June 30, 1969, 1970, 1971, and
 2 1972;" and (B) by adding at the end of the subsection
 3 the following sentence: "On or before January 20 of each
 4 year, the Secretary shall submit to Congress a report setting
 5 forth operations under this Act during the preceding calen-
 6 dar year and projecting needs for the ensuing calendar year."
