

Title: **Susan Ursin Niemcewicz with Peter and Sarah Van Horn, May 2, 1829**

Contract made this second day of May in the year of our Lord one thousand eight hundred and twenty nine between Susan U. Niemcewicz of the one part and Peter Van Horne and Sarah his wife of the other part. The said Susan U. Niemcewicz having by an instrument bearing even date herewith, duly and legally manumitted and freed the said Peter Van Horne and Sarah his wife and agreed to pay them for their services during the term of her natural life, the yearly compensation of one hundred Dollars, from and after the first day of April in the year one thousand eight hundred and twenty nine, payable at and after the decease of the said Susan U. Niemcewicz and they the said Peter Van Horne and Sarah his wife having agreed to serve her the said Susan U. Niemcewicz during her natural life to the annual compensation aforesaid payable as aforesaid now, this contract witnesseth that the said Susan U. Niemcewicz covenants and agrees to and with the said Peter Van Horne and Sarah his wife that in case they shall do her good and faithful service, performing her legal directions and obeying her lawful commands during the period of her natural life she will cause to be paid to the said Peter Van Horne and Sarah his wife immediately after her decease the sum of one hundred dollars for each and every year from and after the first day of April last part during which the said Peter Van Horne and Sarah his wife shall have performed such service, as aforesaid: and will furnish them during the term of such service good and sufficient food and clothing. And the said Peter Van Horne and Sarah his wife do hereby covenant and agree to and with the said Susan U. Niemcewicz that they

will during the period of her natural life render her good and faithful service performing all her legal requirements and obeying all her lawful commands, as good, honest, faithful and obedient servants should do. It being expressly understood and agreed that the true and faithful

performance of the terms of this contract Upon the part of the said Peter Van Horne and Sarah his wife are a condition precedent to the liability of the said Susan U. Niemcewicz and dependant entirely upon their faithful fulfillment of its provisions. In case of the death of the said Peter Van Horne and Sarah his wife in the lifetime of the said Susan U. Niemcewicz the wages which they shall have earned shall be paid to their son Robert at his arrival at the age of twenty five years in case he shall have faithfully served out his time according to laws.
