Abstract

The New Jersey Collection consists of maps, atlases, rare and New Jersey books, pamphlets, and manuscripts. Also included are facsimile maps and reproductions of manuscripts. The manuscripts include correspondence, financial records, legal documents, and other miscellaneous materials. The bulk of the collection is related to New Jersey people, businesses, and places.

History

The New Jersey Collection was created in 1977 at the bequest of former librarian Nancy Thompson. The collection moved into the Liberty Hall Academic Center & Exhibition Hall Special Collections Research Library & Archive in August 2019.

Scope and Content

The collection includes 3,000+ rare and out-of-print books, first editions, early New Jersey imprints, manuscripts, documents, pamphlets, almanacs, prints, maps, and ephemera.

Manuscripts and Print

The manuscripts include letters, copies of civil war letters, financial accounts, and bound ledgers. The printed material includes brochures, pamphlets, broadsides, newsletters, and books. The folders are not consistently labeled. A local book about a town may be labeled based on the author, title, or location. There can be a file with one advertisement inside, versus material that should be its own collection (there are 17 manuscript boxes for the Plainfield Grand Army of the Republic Collection). There are accession records for these items that are filed at the end.

This file contains two copies of the "Atlantic City Boardwalk Illustrated News," one from December of 1929, and the other from October of 1929. It also contains a few loose sheets from the magazine, two scraps of unidentified paper, as well as a 1930 roadmap of New Jersey. The magazines have illustrated and colorful covers, but are black and white on the inside. The content of the October magazine includes news concerning Atlantic City, as well as information about and numerous pictures of well-known persons staying in the city (senators, businessmen, etc.). Interspersed throughout the magazine are full-page ads for various businesses within the city. Within the December issue, the format is similar, albeit with more focus on the Christmas season.

There are five boxes, but only two have been described:

The files contain several folders related to transportation that are listed below. The first folder contains black-and-white pictures of New Jersey trains, including newer aluminum trains from the 1960s and 70s, as well as older trains built in the early twentieth century.

Two folders contain information regarding the Port Authority Trans-Hudson (PATH) Corporation. Documents in these folders contain rail maps, diagrams of stations, pamphlets and other publications containing information about PATH and train schedules. Several documents within the folder relate to PATH in the 1960s. One interesting piece within the smaller PATH folder is a small pamphlet about the oldest transit car in service at the time (from 1909 to 1965).

Another folder contains a news article from October 18, 1964 about the fight to preserve commuter railways in Morris County, which had been suffering deficits of \$5 million annually.

The next folder contains a short document on the history of public transportation in New Jersey. The document was written by Chief Traffic Investigator Christopher J. Schmitt in 1965.

The next folder contains a magazine on the history of the Reading Railroad, dated to 1958. Included in the book are maps and a chronology going back to 1825. Several pictures of the railroad, trains, and passengers are found throughout the book.

The next folder holds two copies of a book titled "Scenic & Historic Tours of New Jersey: Crossroads of the Revolution." The book can be dated to the 1970s or 1980s and details various routes around New Jersey which pass by historic sites. Each tour is presented in the roads a traveller should take, and these roads are illustrated, including the towns they pass through. Illustrations of many historic sites along these tours are also present.

This file contains several folders containing issues of the Texas Division of the Electric Railroaders Association's "Short Circuit Bulletin." These issues do not appear to be in any particular order, but span a time between 1976 and 1980. The bulletins discuss electric rail transportation throughout the United States, and include pictures of rail cars, maps of rail systems, as well as letters from individuals interested in various aspects of the electric rail transportation.

The next folder contains a small pamphlet titled "Testimony of Thomas N. McCarter on the Economics of the Transport Situation." It is dated to April 17, 1930 and spans about twenty-five pages. At the end of the pamphlet, a page opens out to show a comparison of streetcar and bus lines in Essex county in 1915 and 1930.

The next folder contains three black-and-white paper booklets of "The Transfer Table," from summer and fall of 1965, and summer of 1967. The issues deal with news and economic reports related to rail transit, and include images of rail cars.

Another folder includes an incomplete collection of issues of "Transport News" from February 1961 to October 1970. These issues consist of news related to transportation in New Jersey,

The subsequent folders contain various booklets and pamphlets relating to transportation, especially railroads. One item is an album of sorts, with many pictures of New Jersey rail cars. Another is an almanac of Union County, with images and short descriptions of notable historical events which occurred throughout the county. There is also a transportation study of Union County,
